Dear Superintendent Carol Woodbury:

The Department of Elementary and Secondary Education (MA DESE) and local education agencies (LEAs) across the Commonwealth have made it their priority to increase educational access and equity for our most marginalized students, especially students with disabilities. This priority necessitates that we identify inequities in special education and respond to them. As part of this work, MA DESE implements multiple initiatives.

The purpose of this email is to notify your LEA of its status across these initiatives and indicators for the 2022-2023 school year. It is recommended all district staff carefully read all information in this email as if flagged or identified there will be required actions of the LEA.

MA DESE is working to create a system of technical assistance, professional development, and other supports that is customized for each LEA. This will include district level supports, professional learning communities (PLCs), and online trainings.

For LEAs identified or at-risk of significant disproportionality in special education and LEAs flagged or identified for indicators 4, 9 and 10, you will receive an email with more information about requirements, upcoming technical assistance opportunities and PLC groups.

Significant Disproportionality in Special Education: IDEA requires states to measure whether students from certain racial and ethnic groups are disproportionately receiving special education services in specific disability categories, whether they are disproportionately placed in certain settings, and whether they are disproportionately receiving certain kinds of disciplinary removals. IDEA requires different calculations for this measurement than it requires for Indicators 9, 10, 4A, and 4B.

LEAs identified with significant disproportionality are required to complete the following:

- 1. Review and, if appropriate, revise policies, practices, and procedures (PPPs)
- 2. Publicly report revisions of PPPs
- 3. Reserve 15% of IDEA funds for comprehensive coordinated early intervening services (CCEIS) to address factors contributing to the significant disproportionality. Funds must be used for students ages 3 through grade 12 and for students with or without disabilities.
- 4. Identify and address factors that may be contributing to significant disproportionality
- 5. Submit action plans to DESE for approval in spring 2023. More information on these action plans will be included in follow-up email.

Though at-risk LEAs are not required to take specific action right now, they may wish to assess their policies, practices, and procedures for reasons that may have contributed to the LEA's high risk ratios or take additional steps to examine the data that suggest disproportionality.

Any LEA at-risk for future identification with or identified with significant disproportionality is invited to participate in the MA DESE provided technical assistance and professional development.

Indicators 4A and 4B are required by the Individuals with Disabilities Education Act (IDEA) and, through data analysis, measure whether students with IEPs, overall and from certain racial and ethnic groups, are suspended or expelled in LEAs more than students with IEPs statewide. Through this data analysis LEAs are identified for indicators 4A and 4B.

All LEAs identified by way of this data analysis are required to identify and address factors that may be contributing to disproportionality. LEAs found to have policies, practices, and procedures (PPPs) that lead to this discrepancy are required to write a corrective action plan which must be completed by the next reporting year.

Any LEA identified under indicators 4A and 4B are invited to participate in MA DESE provided technical assistance and professional development

Indicators 9 and 10 are required by IDEA and, through data analysis, measure whether students from certain racial and ethnic groups are disproportionately receiving special education services in LEAs, both in general

and in specific disability categories, because they were inappropriately determined eligible for special education services. Through this data analysis LEAs are flagged for indicators 9 and 10.

All LEAs flagged by way of this data analysis are required to send PPPs to MA DESE. IDEA requires MA DESE to determine whether the disproportionate representation is due to inappropriate identification of students for special education services by reviewing the LEA's PPPs regarding disability determination and eligibility determination. If it is determined that PPPs are inappropriate and are contributing to the disproportionate representation, corrective action procedures are required.

Any LEA flagged under indicators 9 or 10 are invited to participate in MA DESE provided technical assistance and professional development.



Minutes of a School Committee Meeting

Monday, September 19, 2022

A Dennis-Yarmouth Regional School Committee meeting was held on Monday, September 19, 2022, at the Dennis-Yarmouth Regional High School Library in South Yarmouth, Massachusetts.

Members Present: Jeni Landers, Vice Chairperson; Tomas Tolentino, Treasurer; Jennifer Rose, Secretary; Phillip Morris; Marilyn Bemis; and Joe Glynn.

Members Not Present: Joseph Tierney, Chairperson; Student Representative Kristen Stagg.

Others Present: Carol Woodbury, Superintendent of Schools; David Flynn, Assistant Superintendent for Finance and Operations; Maria Lopes, Assistant Superintendent of Student Services and Instruction; Eileen Whalen, Recording Secretary to the School Committee; Betsy Pontius, Director of STEM; Michael Bovino, Principal, Mattacheese Middle School; Tim Blake, Principal, Nathaniel Wixon School; Pam Fee, School Psychologist, Dennis-Yarmouth Regional High School; Michelle Dunn, DYEA; Paul Hilton, Patrick Murphy, Cape Cod Collaborative.

At 6:30 p.m., Jeni Landers, Vice-Chairperson, called the meeting to order.

Reports:

Student Representative Report - Kristen Stage

Kristen had a field hockey commitment so was unable to attend the meeting. She sent a report about the start of the school year at the high school which Vice Chair Landers read: Fall sports are in full swing; club meetings have begun; Dolphin Time has gone well so far; auditions for the play *Animal Farm* went well and rehearsals start on Wednesday. Marching band will have their first competition on Saturday at Blackstone.

Superintendent Report - Carol Woodbury

- Superintendent Woodbury introduced Dr. Pam Fee, School Psychologist, and Tully, the new therapy/emotional support dog at the high school. Dr. Fee shared that Tully started on the first day of school and is doing very well. Aside from spending time with students who come to see Dr. Fee, Tully has visited the WAVE program where she will help the students with social skills. She has visited the medically fragile program where she will help the students practice fine motor skills (holding the leash, treats, etc.). There are plans for her to visit the Alternative Learning Program and Advanced Placement classes. Tully is very comfortable with the students and receives a lot of attention. The committee followed up with a few questions and comments. Tully is a hypoallergenic breed; she comes to school every day; she goes into the halls with Dr. Fee during passing time to become acclimated to all of the students; she has not yet visited the students during lunch in the cafeteria.
- 2. Paul Hilton Cape Cod Collaborative Services

Superintendent Woodbury introduced Paul Hilton and Patrick Murphy from Cape Cod Collaborative Services. Mr. Hilton and Mr. Murphy gave a Power Point presentation on the Cape Cod Collaborative. It is an all-district partnership across the Cape and is an extension of all the Cape's schools. Prior to the meeting Mr. Hilton distributed packets to the Committee which included a copy of the Power Point presentation; the Articles of Agreement; and the most recent Annual Report. Mr. Hilton explained the advantages of the Collaborative including better opportunities for staff and students as well as shared costs. Dennis-Yarmouth is a founding member of the Cape Cod Collaborative which began in 1975. They continually reassess curriculum and staff. Mr. Hilton described the various programs in Sandwich and Osterville. It is not a private school. He mentioned that D-Y has fewer students in the programs than they have in the past. The Waypoint program will be moving into the Laurence MacArthur building sometime in January. The Collaborative meets periodically with Sherry Santini, Director of Humanities and the Arts; Superintendent Woodbury; Assistant Superintendent Flynn, Assistant Superintendent Lopes; and School Committee member Phillip Morris. Some of the other programs sponsored by the Collaborative include an advanced study program at Mass. Maritime; the annual All Cape in Service Day; Virtual High School; and many professional opportunities.

The presentation was followed by questions from the Committee. Mr. Morris welcomed Mr. Hilton and Mr. Murphy and said he is honored to be on the Board of Directors for the Cape Cod Collaborative. It is an impressive organization and supports good programs. Vice Chair Landers asked about the decreased D-Y enrollment and asked if that is a trend across the Cape. Mr. Hilton indicated that it is the exception this year.

Vice Chair Landers and Superintendent Woodbury thanked Mr. Hilton and Mr. Murphy for the presentation. Mrs. Woodbury added that the Collaborative is working to help special education teachers receive waivers through Bridgewater State University; this is happening all across the Cape. Mr. Morris told the committee that digital copies of the Collaborative meeting minutes are available.

3. Transportation of Students Policy and Practices

Superintendent Woodbury referenced the memo which was included in the packet. As indicated in the memo, bus transportation can be very challenging. Families move; new students are added; for instance. Additional group stops have been added this year. Also, not every child uses the bus. It is hoped that some of the stressors could be alleviated by asking families to sign up for a bus pass. There will be no charge. It is anticipated that this will be a mid-year change, coinciding with the opening of the new intermediate-middle school. Another idea is to establish group stops that remain the same from school year to school year. Assistant Superintendent Flynn said that some students never ride the bus and that utilizing a bus pass system will identify those students right from the start, thereby making things more efficient. He noted that the order of the elementary school bus stops may change because all of the buses will be leaving directly from D-YIMS for the elementary school run. The Committee followed up with questions. Vice Chair Landers would like the district to let families know about any bus changes as soon

possible. Ms. Landers added that she likes the idea of regular stops from school year to school year.

4. Good News

Superintendent Woodbury announced the retirement of Sandy Cashen, Facilities Director, thanking her for her 32 years of service to the district. Mrs. Woodbury indicated that under the Building Committee report there is an item on the agenda to amend the School Building Committee Membership roster naming David Flynn as the MCPPO for the Dennis-Yarmouth Intermediate School project. Ms. Cashen will remain on the Building Committee. The first furniture delivery date for the new school is October 17th. She then shared the dates for the upcoming open houses. She indicated that there are daycare openings for staff at the elementary schools. Mr. Tolentino added that there are currently 63 students on the Station Avenue waiting list for daycare.

Superintendent Woodbury shared Good News from all around the district:

Ezra Baker Innovation School

The school year has started well! This September, we welcomed 343 Pre-K through third grade students! This is quite a jump from our last year's opening, due largely to the addition of a fourth Pre-Kindergarten classroom for 3 and 4 year old learners! We are eagerly awaiting our first in person Open House since 2019 on Thursday, September 22nd, beginning at 6:00 PM. Our year is in full swing, including daycare both before and after school. As we begin our 11th year as an Innovation School, we are excited to share our revamped set of core values:

- Honors their Academic, Physical, Social, and Emotional Needs,
- Embeds and Practices Diversity, Equity, and Inclusion, and
- Values Arts Education and Community Service

MES is buzzing with excitement for the start of the school year! It is wonderful to welcome our students, families, and staff back to school! Our staff has been hard at work preparing for these first couple of weeks and we are establishing our routines and expectations! Open House is scheduled for September 20th from 6-8 PM! Families and students will have the opportunity to visit the school to meet their teachers, check out classrooms, and learn about some of our school and community resources. This donation will fund academic resources needed for our students. Building on our collaborative, team-based approach, our school is determining the specific resources by grade level teams.
