RE: Recommended Revised Vote for FY 2024 Budget

After reviewing the proposed budget for FY 2024, I am recommending the use of \$300,000 from Certified Excess and Deficiency (E & D) as a Revenue source to partially offset the FY 2024 debt payments on the High School bond. With the assessment on this bond being split 39.055% for Dennis and 60.945% for Yarmouth, this will lower the overall assessment to Dennis by \$117,165 and lower the overall assessment to Yarmouth by \$182,835.

Please refer to the revised Revenue Projection and Debt Service Schedule (attached). The total budget for FY 2024 will remain the same at \$76,019,508.

This would require the following revised vote of the School Committee.
