At 6:32 p.m., Jeni Landers, Chairperson, called the meeting to order.

Recognition - Black History Month Essay Winner

Aeva DaBreo - Dennis-Yarmouth Regional High School

Superintendent Woodbury introduced Aeva DaBreo, an 8th grader in Mrs. Economides' ELA class at Dennis-Yarmouth Regional High School. Aeva read her winning Black History Month essay. The Committee, along with Superintendent Woodbury, was very impressed and congratulated Aeva.

Reports:

DYRSD School Committee Student Representatives - Grace LePain and Kristen Stagg

Grace reported on the Winter Guard's first place finish at the regionals in Philadelphia. The NHS blood drive was very successful. The theme for the prom is Enchanted Evening. Kristen reported on the ending of the third term. The spring play is *The Addams Family* and show dates are April 29 and 30.

Policy Review Subcommittee

Superintendent Woodbury informed the Committee that the Policy Review Subcommittee met to review several policies. Those policies are now for review by the full committee at this meeting.

- 1. JKAA Physical Restraint of Students Update (2nd Reading)

 Maria Lopes reported that there have been many changes to the physical restraint policy. Many different layers have been added; a crisis team, Special Education Teachers, and specialized training. There were no questions from the committee regarding this policy.
- 2. AC Non-Discrimination Update (2nd Reading)
 Carol Woodbury reported that these policies come from MASC and have been reviewed by their attorneys.
 This policy now includes harassment and retaliation as well as school committee affirmations. Joe Tierney asked if most districts in compliance with this policy; Mrs. Woodbury said yes.
- 3. AC-R Non-Discrimination Policy Including Harassment and Retaliation-Update (2nd Reading)

 There were no questions from the Committee.

- 4. ACAB Sexual Harassment Update (2nd Reading)

 The superintendent reviewed this policy; the definition has been expanded to include due process.

 Mr. Morris asked when these policies will appear on the district website; this will occur after the third reading and approval from the school committee. There were no other questions.
- 5. JICK Harassment of Students Update (2nd Reading)

 The superintendent reported that the policy broadens harassment of students to include texting, blogging, and any electronic means. Jeni Landers said that it is important to read all of these carefully; much of this is outside of the committee's control.
- 6. EEA Transportation of Students Update (2nd Reading)
 Policy EEA has been changed to reflect the grade configurations in each school. There were no questions from the committee.

Mr. Tierney reported that all is going well. Mr. Flynn added that he recently toured the site and everything is on schedule and looking great. Mrs. Woodbury added that a tour for the committee is in the works for April 11th at 5:30 right before the next school committee meeting. At 6:37 p.m., Jeni Landers, Chairperson, called the meeting to order.

Reports:

DYRSD School Committee Student Representative - Grace LePain

Grace reported on spring sports, AP exams, and yearbooks. The spring play *The Addams Family* will run on April 29 and 30.

Superintendent Report - Carol Woodbury

Meaghan McDonnell - EL Presentation

District EL Coordinator Meaghan McDonnell, along with Director of Humanities and the Arts Sherry Santini, gave a PowerPoint presentation regarding the English Learners Program. Ms. McDonnell noted that the district uses an asset-based approach; 13% of district students are multilingual with Portuguese, Spanish and Haitian-Creole being the main languages. There are 25 languages in total represented. Numbers of recent arrivals are increasing; many who could not come due to the pandemic are starting to come now. Dennis-Yarmouth is a Sheltered English Immersion district. 98% of district teachers are SEI endorsed. An ELPAC (English Learner Parent Advisory Council) has been established to help families. Ms. Santini told the committee that there had been an in-person ELPAC meeting just prior to the pandemic which was well-attended and well-received. There are plans for another in-person meeting in the fall. There are ESL classes available for parents. There were translators available for kindergarten registration.

The presentation was followed by questions from the Committee. The members asked how the Committee can help; is there separate funding for adult education for parents; would more staff help? The superintendent said that she would like to hire more EL teachers but that housing for teachers in general is very expensive. Grace LePain asked that with all the extra pressure on the district teachers what is being done to support them. Ms. Santini said that the teachers are SEI endorsed, there are many professional development opportunities and course reimbursement; EL assistants are in the classrooms. Chair Landers advised Grace that if she had further questions she could make an appointment with Ms. Santini. Mr. Tierney thanked Ms. McDonnell and Ms. Santini for their informative presentation. He asked where the newcomers are coming from. Ms. McDonnell called it a "pandemic pause" and that it is not unique to our district.
