Reports

DYRSD School Committee Student Representative – Tainan Nunes

Tainan Nunes reported that both senior week and graduation went very well and that students are studying hard for their upcoming finals.

School Committee Liaisons to the Boards of Selectmen – B. Carey, Dennis; J. Tierney, Yarmouth

Brian Carey, Dennis: No report. Mr. Carey expressed his thanks to Mr. Morrison and Ms. Endich for their assistance in making senior week at the high school such a success.

Joe Tierney, Yarmouth: No report.

Superintendent Report – Carol Woodbury: Mrs. Woodbury announced that there will be free breakfast and lunch at the M.E. Small Elementary School next year through the Community Eligibility Provision. M.E. Small is eligible because 40% of the students who receive free lunch qualify directly through the state. Mattacheese Middle School, NH Wixon School, and the Ezra H. Baker Innovation School all qualify for universal free breakfast. Mrs. Woodbury praised Ms. Rooney Powers, Food Service Director, and her staff for all their hard work on behalf of our students. The superintendent then outlined the hiring process for the high school principal. Staff, students, and parents were surveyed regarding the high school principal search; there were 490 respondents. There were thirty applicants of which eight were chosen for an initial interview. Six of those applicants then participated in round-robin style interviews with teachers, staff and students. Feedback from those interviews facilitated a decision to narrow the candidate pool down to the final three. Mrs. Woodbury then announced that Paul Funk will be the new high school principal. Dr. Funk thanked the students and teachers and said he was excited and proud. Several members of the Committee extended their congratulations. Student Representative Tainan Nunes asked Dr. Funk what his main focus will be; it will be student achievement.

School Committee Business

FY20 Budget: Mr. Jenks gave a PowerPoint presentation on the budget. He reiterated that the two towns adopted different assessments. The senate budget update was discussed. It has not yet passed. There are no easy answers. A discussion followed regarding excess and deficiency, foundation enrollment, and the governor's budget.

Dear Superintendent Woodbury:

Your recent letter stated that the member towns of your district have not yet approved a fiscal year 2020 budget. M.G.L. chapter 71, section 16B empowers the Commissioner of Elementary and Secondary Education to order an appropriation for a regional school district when the regional school committee and the appropriating bodies of the member communities have not agreed on a budget. In accordance with this statute, I am authorizing the Dennis-Yarmouth Regional School District to continue its operations and to spend up to \$5,039,261 in each month of fiscal year 2020 until your district's fiscal year 2020 budget has been adopted, or until December 1, 2019, whichever comes first. This interim monthly budget is one-twelfth of the regional school district's budget for the *prior fiscal year*.

Each member community within your district is ordered to appropriate and pay to the district such assessments as are calculated by the district treasurer for the support of said interim budget. The district treasurer must use the statutory method, as defined in CMR 41.01, to prepare the member town assessments. Said assessments shall be due and payable on such dates as are specified in your regional agreement. Each member community's total payments under this order will be deducted from the total fiscal year 2020 assessment that will be charged to that community when the district's fiscal year 2020 budget is approved.
