2021 Assessment and Accountability Update

As students return to classes this week, the Department of Elementary and Secondary Education (Department) remains committed to supporting school and district leaders who are managing the challenges of teaching and learning during the pandemic. The return from winter break marks the start of testing windows for federal and state-mandated student assessments. Administering these assessments, including the Massachusetts Comprehensive Assessment System (MCAS) and the ACCESS language proficiency test for English learners, can be logistically complex even in ordinary times. Administering these assessments this year is understandably a concern for local communities.

The sudden shift to remote learning last spring, and the continuation of hybrid/remote learning this school year has likely led to significant learning loss for students around the country. The extent of the learning loss in the Commonwealth is not yet known.

The Department continues to believe the MCAS test is a crucial diagnostic tool to promote student success and educational equity and we remain committed to administering the assessment this spring, while recognizing the need for adjustments and flexibility.

A national study released last month by McKinsey & Co. estimates the shift to remote learning in spring 2020 set back all students' academic progress by months. The study predicts learning losses will escalate as students remain in remote/hybrid models this academic year. The magnitude of this potential impact demands that we accurately and fairly assess the level of student learning this school year.

The MCAS tests will give Massachusetts educators and families critical insight into academic losses that need to be addressed this spring and summer, and data on which students and districts have been most impacted by the disruptions in schooling. Administering the MCAS will make it possible to reliably assess students' progress in relation to curriculum standards.

Besides serving this essential diagnostic purpose, the high school MCAS also affirms that students are prepared for college and careers, in addition to providing access to college

scholarships.

The Department will take the following steps to modify testing this spring:

- Modify the Competency Determination for the Class of 2021: The make-up MCAS administration window for 12th graders scheduled to open on January 14th will be postponed. I will recommend to the Board of Elementary and Secondary Education (Board) that the competency determination (CD) requirement be modified in English language arts and mathematics for students in the Class of 2021 who have not yet earned their CD.1 The recommended modification would allow students to receive their CD by passing an approved course and demonstrating competency in that subject in lieu of a qualifying MCAS score. Seniors who still want to take the tests may take them later this school year. Members of the class of 2021 will have opportunities to receive additional academic support this spring and summer.
- Shortened MCAS testing time for Grades 3-8: The Department will significantly reduce testing time for students in grades 3-8 through a session sampling approach, in which each student will take only a portion of each MCAS assessment in each subject. This modified MCAS administration will preserve the validity and reliability of the test at the school, district, and state levels. When combined with other data points, this approach will provide meaningful diagnostic data at the individual student level.
- Accountability relief: I will not name or recommend to the Board any new underperforming or chronically underperforming districts or schools in the upcoming school year. The Department will also consider any available flexibilities provided by the U.S. Department of Education.
- Extending ACCESS testing window: ACCESS testing for English language proficiency is key to strengthening education programs for English learners. As previously announced, the Department is extending the testing window for ACCESS, which normally concludes in February, until May 20, 2021.
- MCAS Biology test: The Department has provided school districts flexibility on scheduling the high school biology MCAS test. Schools may offer the biology MCAS to first-time 9th graders in June, instead of or in addition to offering it in February.

These testing flexibilities announced today are one part of the Department's broader goals to support districts and schools in the second half of the current school year, during the summer, and into next school year. In the coming weeks, the Department will release additional information, including preliminary plans and resources to support districts and schools in addressing student learning loss.



DENNIS-YARMOUTH REGIONAL SCHOOL DISTRICT Minutes of a School Committee Meeting Monday, December 7, 2020

A Dennis-Yarmouth Regional School Committee meeting was held on Monday, December 7, 2020, at Mattacheese Middle School, West Yarmouth, Massachusetts. Because of the Governor's order limiting indoor public gatherings to 25 persons the public was invited to participate in the meeting via Zoom technology.

<u>Members Present:</u> Jeni Landers, Chairperson; Joseph Tierney, Vice Chairperson; James Dykeman, Jr., Secretary; Brian Carey, Treasurer; and Phillip Morris.

Members Absent: Joe Glynn.

Others Present: Carol Woodbury, Superintendent of Schools; Kenneth Jenks, Assistant Superintendent for Administrative and Business Services; Tainan Nunes, Student Representative to the School Committee; Eileen Whalen, Recording Secretary to the School Committee; Mike Bovino, Principal, Mattacheese Middle School; Will Rubinstein; Vida Morris.

At 6:50 p.m., Jeni Landers, Chairperson, called the meeting to order.

Reports

<u>DYRSD School Committee Student Representative – Tainan Nunes</u>: Tainan reported on the happenings at the high school. The senior class recently held a fund raiser, Pie it Forward; which raised over \$800.00. Winter sports have started. Principal Paul Funk has established the Principal's Leadership Council; students who wish to join should contact Dr. Funk. The math team is very strong this year. The school has an ESports team; they play sports and video games and play teams from all over the state. People can watch on Twitch. Next week is ugly sweater week.

School Committee Liaisons to the Boards of Selectmen:

Brian Carey, Dennis: Mr. Carey reported that Jennifer Rose of Dennis will be taking over his seat on the school committee. He said that this will most likely be his last meeting. He thanked the members of the committee; the superintendent and assistant superintendent. He also acknowledged Representative Tim Whelan for all of his help with the MSBA and the new intermediate/middle school. He ended by thanking his wife Christina and their sons for their support during his ten-year tenure on the School Committee.

<u>Joseph Tierney, Yarmouth:</u> Mr. Tierney reported that Brian Sullivan has stepped down from the school committee and that nominations will be taken for a replacement until the end of the year. The selectmen will choose the replacement. Tracy Post has offered to step in. Mr. Tierney also mentioned an upcoming public forum regarding the wastewater project.

<u>Building Committee Report – Joseph Tierney</u>: Mr. Tierney reported that the bid process continues.

On a motion by Joseph Tierney, seconded by James Dykeman, and carried unanimously by a 5-0 vote, it was

VOTED: To appoint Mr. Gary Barber to the school building committee.

<u>Assistant Superintendent Report – Kenneth Jenks</u>: Mr. Jenks gave a brief overall update. The budget is being finalized. This has been a year requiring patience. Cleaning, sanitizing, and maintenance are ongoing. Bus windows and classroom windows will need to be open during the cold weather; students and staff should dress accordingly.

Superintendent Report – Carol Woodbury: Mrs. Woodbury gave the committee an update on COVID-19. We have been very fortunate to be able to keep schools open. Three new classrooms opened as of today at the M.E. Small Elementary School for students returning to inperson learning. The return of remote students has not gone as quickly as we would like because of the 6-foot distancing. There has been no school-based spread. The superintendent gave a shout-out to District Nurse Leader Kristin Dwyer. Kristin is involved in the handling of every suspected COVID case. When there has been a confirmed case families have been very cooperative and understanding about the need to quarantine and go remote. The superintendent repeated the need for bus and classroom windows to be open to let air circulate. She also reminded everyone to remain vigilant about wearing masks, washing hands, and socially distancing.

At this time Chair Landers thanked Mr. Carey for his service to the district. Mr. Brian Sullivan has resigned from the Committee effective December 4, 2020; she thanked him for his service to the district.

School Committee Business

Committee's Response to Public Comments from November 16, 2020 Meeting:

<u>Phillip Morris</u>: Mr. Morris reiterated that communication, responding to issues and reassurance are all very important.

Brian Carey: Mr. Carey said he wished Mr. Glynn were present at the meeting. He said that the committee is not the enemy.

<u>Jeni Landers</u>: Chair Landers said that Mr. Glynn's posts reflect badly on the school committee even if they are his own personal posts. She said that it is unfortunate that he has not attended the last two meetings.


